Work to include foundations, framing, roofing, doors, windows, electrical, mechanical, plumbing, plumbing fixtures, insulation, drywall, siding, flooring, interior finish work and hardware, interior/exterior painting, appliances, furniture, and all other incidentals necessary for a complete and functional facility meeting all applicable NEPA, Klamath Tribes Cultural survey/monitoring and local building code requirements.

 - d. Asphalt shingle or metal panel finish roofing over roof diaphragm sheathing per structural drawings.
- 2. Two (2) stick framed changing rooms of approximately 144 square feet each, to include, but not limited to:
 - a. Concrete pier foundation per structural drawings
 - b. Conventional wood framing, per structural drawings to include:
 - i. Pressure treated mudsill
 - ii. Dimensional lumber Wall studs per structural drawings
 - iii. Dimensional lumber wall top plates per structural drawings
 - iv. Dimensional lumber rafters per structural drawings
 - v. Ridge beam per structural drawings
 - vi. Wood structural panel exterior sheathing per structural drawings
